ORGANIZER

Participants are free to choose the order of cable car rides and slopes between them. After completion, participants automatically receive a message at the email address provided in their personal Skiline account. This message serves as the only confirmation of the successful completion of the Trophy and is also the only authorization to participate in the prize draw.

For the prize draw, there are 3 pots: GOLD for 1 day, SILVER for 2 days, and BRONZE for 3 days. Trophy graduates are assigned to the pots according to the required time (1, 2, or 3 days).

The draw takes place privately after the winter season 2023/24. Winners will be notified by email.

PRIZES

- In the GOLD pot: 3 pieces of 365 ACTION ALPIN CARD (annual passes) for 2024/25
- In the SILVER pot: 3 pieces of SKI ALPIN CARD (season passes) for 2024/25

VIOLATION OF PARTICIPATION CONDITIONS
